Terms and Conditions

Competition Terms and Conditions:

PROMOTER

1. The promoters of this competition are the Partners of Le Gallais & Luce, PO Box 696, 6 Hill Street, St. Helier, Jersey, JE4 8YX ("LGL").

THE COMPETITION

2. This competition involves the chance to win a free prize by locating a hidden Gonk and subsequently attending at the reception of LGL to claim the prize. The Competition (the "Competition") is as set out within these terms and conditions.
3. The Competition will be run on a daily basis over the course of 9 weekdays between Tuesday 3rd December 2024 and Friday 13th December 2024 (the "Competition Period"), during which there will be a Gonk to be found each day, with each Gonk relating to a different daily prize.
4. Each day during the Competition Period LGL will post and share cryptic clues ("the Clues") on LGL's Instagram page (<https://www.instagram.com/legallaisandluce/>) and LGL's Facebook page ([Facebook](#)). The first cryptic clue will be posted and/or shared at or about 12:00 noon and the second and final clue will be posted and/or shared at or about 12:30. The location of the Gonk may be ascertained from the Clues.
5. The winner of the Competition each day shall be the first eligible person who is observed to pick up the Gonk hidden for LGL (the "Daily Winner"). Each Gonk, when it is found by an eligible participant, shall become the property of the finder. The location at which the Gonk is hidden will be monitored by a member of staff employed by LGL (the "Employee"), by whom the person who is observed to first pick up the Gonk will be approached at the scene by the Employee, who will identify themselves as such. Once a party has been determined by LGL to be a Daily Winner that party may not re-enter the Competition during the Competition Period.
6. In order to claim their prize each Daily Winner must provide to the Employee at the time that they are approached their full name together with a valid telephone contact number, email address and residential contact address together with proof of age if so requested, and agree to have, and permit, a photograph or photographs to be taken by the Employee at the date and location when they find the Gonk as well as when collecting their prize.
7. Each Daily Winner shall, as a condition of entry to the Competition, have agreed for their name and photograph(s) to be used at the discretion of LGL for such promotional activities as LGL shall determine.
8. Each Daily Winner shall be entitled to receive the daily prize ("Daily Winner Prize"). LGL reserve the right to substitute an alternative Daily Winner Prize at their absolute discretion.
9. The Daily Winner Prize is non-transferable and non-refundable and each Daily Winner cannot elect to receive cash, or an alternative item, in place of the Daily Winner Prize.

GENERAL

10. The Competition is open to anyone aged eighteen (18) years of age or over except for LGL employees and their immediate families or a previous Daily Winner during the Competition Period as stated in clause 5 above. The following shall constitute the immediate family of an employee of LGL: a spouse or civil partner, a child/children, sibling(s), a parent(s).
11. No purchase of any sort is necessary to enter the Competition and there is no charge to enter. Any additional costs incurred are the responsibility of the Competition entrant.
12. The Daily Winner Prize, or a voucher for the same to be redeemed from a specified third party provider, will be available for collection from the offices of LGL between 9:00 a.m. and 5:00 p.m. during normal weekdays during the course of the Competition and shall remain available for collection until 12.00 p.m. on Tuesday 24th December 2024 (the "Collection Date").
13. If the Gonk for any or all of the daily competitions remains unfound, or if the Daily Winner Prize is not claimed by the Daily Winner from the reception of LGL by the Collection Date, then such Daily Winner shall forfeit their Daily Winner Prize and LGL will donate the unclaimed Daily Winner Prize or the value of that unclaimed Daily Winner Prize to its chosen charity, Brightly Jersey.

14. The Daily Winner of each Daily Winner Prize is subject to verification of the Daily Winner by LGL, and LGL may refuse to provide the Daily Winner Prize until the Daily Winner has been verified to the satisfaction of LGL.
15. LGL may in its absolute discretion vary or terminate this Competition at any time.
16. All instructions issued by LGL in relation to this Competition form part of these conditions.
17. LGL reserve the right at their sole and absolute discretion to refuse and/or ban any person or persons from entry to and/or participation in the Competition, either on any particular date during the Competition Period or during the Competition Period as a whole.

To the full extent permitted by law, LGL and its associated companies and any agencies (the "Relevant Parties"), exclude all and any liability for any loss (including any damage, claim, injury, cost or expense) whatsoever which is suffered or incurred by any person arising out of, or in any way connected with the Competition and/or all or any Daily Winner Prize including without limitation:
 - (a) any direct, indirect, economic or consequential loss; and/or
 - (b) any loss arising from any negligent act or omission of any Relevant Parties.
19. LGL will not accept liability for any entry or entries lost or damaged, nor for any associated costs to claimants.
20. Each Gonk is not a toy and should not be given to children or animals. The Gonk may itself be and/or contain a choking hazard, and/or toxic substances if eaten. Medical advice should be sought immediately if effected.
21. When honouring any discount or promotion awarded by LGL in connection with the Competition, LGL reserve the right to verify that the individual and/or entity purporting to claim the discount and/or promotion is entitled to receive the same and may at their sole and absolute discretion refuse to award the discount and/or promotion if such evidence is not provided. This may include the production of proof of employment from any sponsor company of a Gonk for the Competition.
